

Rongomai School (1468)

Enrolment Scheme

Effective from Term 2 2021

The guidelines for development and operation of enrolment schemes are issued under section 11G (3) of the Education Act 1989 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below and/or shown on the attached map shall be entitled to enrol at the school.

Starting at the intersection of Preston Road and Rapson Road, travel north along Preston Road (even addresses 112 – 174 only included and odd addresses 125-201 only included) to Kudu Road. From Kudu Road (even addresses 30 and above only included and odd addresses 29 and above only included; Birch Place included) travel north to Dawson Road.

From Dawson Road (odd addresses 69 and below only included and even addresses 62 and below only included; Haumia Way, Desmond Place, Dunstan Place, Coombe Avenue, Murray Road, Collett Road, Windsor Place, Rongomai Road, Wynton Place included) travel north to Ferguson Road.

From Ferguson Road (even addresses 62 and above only included and odd addresses 81 and above only included; Wroughton Crescent, Athelstan Place included) travel north to Capstick Road (even addresses 26 and above only included and odd addresses 19 and above only included; Civil Place, Ivon Road included; Sandra Avenue (even addresses 12 and above only included and odd addresses 15 and above only included)).

All residential addresses on included sides of boundary roads and all no exit roads off included sides of boundary roads are included in the zone unless otherwise stated.

Special Programmes

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

Out of Zone Enrolments

Each year the board will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The board will publish this information by notice in a daily or community newspaper circulating in the area served by the

school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolment will be processed in the following order of priority:

First Priority This priority is not applicable at this school because the school does not run a special programme approved by the Secretary for Education.

Second Priority will be given to applicants who are siblings of current students.

Third Priority will be given to applicants who are siblings of former students.

Fourth Priority will be given to any applicant who is a child of a former student of the school.

Fifth Priority will be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.

Sixth Priority will be given to all other applicants.

If there are more applicants in the second, third, fourth, fifth, or sixth priority groups than there are places available, selection within the priority group must be by ballot conducted in accordance with instructions issued by the Secretary under Section 11G(1) of the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
